### POWER SKATING:

Drills will teach each player to skate 'from their core' increasing the efficiency, power and agility of their skating technique

• <u>OVERSPEED:</u>

Emphasis on quickness to increase acceleration and agility with and without the puck

EDGE CONTROL AND BALANCE:

Focus on lowering the center of gravity will allow athletes to negotiate power turns and changes of direction quicker and with more control

• <u>PUCK HANDLING:</u>

Learn proper puck handling and control in game-like atmosphere

### <u>PUCK PROTECTION:</u>

Focus on protecting the puck in game-like situations with a strong emphasis on placing your body between the puck and the opponent
